2024 AOM International Management Division revised domain statement

The general objective of the Division is to promote scholarship and advances in the field of international business, including management in a broad range of both profit and nonprofit organizations. The Division brings together a global community of scholars researching and teaching management themes with a cross-border or cross-cultural dimension, including not only traditional management topics, but also the contribution of management to addressing evolving global social and environmental challenges. Scholarship that focuses on a single country and has no international issues or implications is not within the purview of the IM division. Members of the IM community conduct research on themes such as:

- the cross-border management of operations, including multi-country, multi-unit, strategy formulation and implementation;
 - the cross-border differential impact of cultural, social, economic, technological, political, and other institutional forces on strategies, organizational forms, and management practices;
 - evolving forms and management practices in cross-border business using physical and virtual channels supporting international business activities;
- the international competitiveness of entrepreneurs, firms, industries, and nations;
- comparative management studies involving two or more countries;
 - the impact of multinational enterprises on the societies in which they operate, and their contribution to global challenges such as social inequalities and climate change.

Program Development is Under Way

Thank you to all the colleagues who have offered to contribute to the 2024 conference program of the IM Division of the AOM. By the deadline of January 10, we have received a total of 458 submissions that are now going through the review process. This includes exactly 402 paper submissions, along with 39 proposals for symposia and 17 proposals for professional development workshops.

I have already noted some very thought-provoking symposia proposals, and interesting new perspectives on teaching international management. Aligned with the conference theme “**Innovating for the Future: Policy, Purpose, and Organizations**”, I see a substantial number of submissions exploring international dimensions of innovations, and of various dimensions of managerial responsibility. In terms of keywords, I also see an increasing interest in the political dimension of international business as reflected in keywords such as geopolitics, political conflicts, and de-globalization. Also, the digital economy is likely to feature prominently within the IM Division program at AOM 2024.

A total of 378 scholars have signed up to review papers, and will have received their reviewing assignments in mid-January. Your contribution as a reviewer is highly valued not only by authors aiming to further develop their work, but by myself and my team who will be putting together the program. Based on the reviewer feedback, we will also be developing shortlists for the IM Division’s paper awards, which will then be assessed by the research awards committee. 

The IM Division will conduct a **Paper Development (PD)** at the forthcoming 2024 Annual Meeting of the Academy of Management in Chicago, USA (the event is most likely to take place on **Sunday, August 11th, 2024** and exact timing to be announced when the program is finalized).

This is the 10th year when the IM Division has been organizing the Paper Development Consortium (PD) at the AOM Annual Meeting. As one of the three consortia organized by the IM Division, this PD aims to provide junior scholars with developmental and constructive feedback from a panel of seasoned and current editors at top tier management and international management journals on crafting and publishing international management research. The PD starts with a panel discussion of crafting and publishing research with both local relevance and “global” impact, followed by a roundtable session in which each participant will receive paper feedback from designated **panel members** and other participants. Dr. Yadong Luo holds the Emery Findley Distinguished Chair and is Professor of Management at the University of Miami Herbert Business School. He is a fellow of the Academy of Management (AOM) and the Academy of International Business (AIB).



With a prolific output, Dr. Luo has authored over 20 books and more than 200 research articles, including over 60 in UT-Dallas Journals-listed publications. His work spans a broad range of subjects, from global strategy and cooperative alliances to cross-cultural management and emerging market businesses. Dr. Luo's outstanding contributions to international management have garnered widespread recognition, establishing him as one of the leading scholars in international management, according to various rankings. His numerous honors include the JIBS 50th Anniversary Gold Medal, the AOM Educator Award, the University of Miami's Lifetime Achievement Award, and the Axiom Gold Medal for his recent book "The Digital Multinationals" (MIT, 2022). His work has significantly enhanced the understanding of various cutting-edge topics in international business, such as the internationalization of emerging market firms, global competition, geopolitical risks, and digital globalization. This is further evidenced by his impressive H Index of 112 and over 55,800 citations on Google Scholar.

She has served the AACSB (Association to Advance Collegiate Schools of Business) as a member of its Board of Directors and European Advisory Council (2012-2014). In addition, Prof. Boyacigiller has served on the advisory boards of WU (Vienna University of Economics and Management), CIIM, the Cyprus International Institute of Management and GIBS of the University of Pretoria in South Africa. She served two terms on the board of Turkish Philanthropy Funds and continues to support their work.

Jackson studies culture and globalization through two distinctive research streams. His second research stream elucidates how multicultural experiences (e.g., working abroad, intercultural relationships) shape key organizational outcomes, including leadership, creativity, and ethics.

Eligibility Criteria

- The award competition is open to all Ph.D. and D.B.A. students who have successfully completed their dissertations during the 2023 calendar year.
- Dissertations submitted to other competitions are eligible.
- All applicants must be members of the IM Division. If you would like to submit your dissertation for this award but are not yet a member of the IM Division, you can sign up by visiting this link, click on "IM" in the interactive chart, and then click the "Join" button.
- The dissertations must contribute to basic or applied knowledge on topics within the domain statement of the IM Division. These can relate to cross-border or cross-cultural issues that influence individuals, teams, organizations, regions, nations, or the world as a whole. Traditional topics related to multinational enterprises and cross-cultural management are within the IM Division domain (see below), but others such as those related to UN sustainable development goals, social justice, diversity, migration, and the like in an international context also fit the IM Division.

Domain Statement: International Management focuses on content pertaining to the theory, research, and practice of management in various global settings. Major topics include: the cross-border management of operations, including multi-country, multi-unit, strategy formulation and implementation; evolving organizational forms and management practices in cross-border business; the cross-border differential impact of cultural, social, economic, technological, political, and other institutional forces on strategies, organizational forms, and management practices; the international competitiveness of firms, industries, and nations; and comparative management studies involving two or more countries.

Submit electronically a 10-page, double-spaced abstract, with margins of one inch (2.54 cm) on every side and in no smaller than 12-point font. This abstract should include the title of the dissertation, a description of the dissertation's objective, theoretical foundations, relation to prior research, methodology, findings, limitations, and contributions to the field of international management.

- Reference lists are not included within the 10-page limit, but all other text, figures, tables or illustrations are included.

Submit the abstract in PDF format, removing any author identification information.

Within the body of the submission e-mail, but not in the abstract file, please indicate your name, the university you graduated from, your dissertation chair(s), and your month and year of graduation.

- Please write "AOM IM Division Best Dissertation Award Abstract" as the subject header.

- Submit your abstract by 31 January 2024.

Evaluation Process

- The IM Division Best Dissertation Award Committee will conduct the first round of reviews of the abstract submissions and select three to five finalists based on the quality of their abstracts.
- The finalists will then submit their full dissertations for further review and selection.

Being selected as a finalist is an honor. Finalists are required to present their dissertations at a specially designed session during the 2024 AOM Annual Meeting. Please submit your abstracts only if you agree with this requirement and agree to attend the division's Business Meeting where the winner will be announced.
